## **Item 4: Other Business Activities**

Mr. McCroskey is a registered representative with Oakwood Capital Securities, Inc. ("OCS"), an SEC registered broker-dealer, member of FINRA and affiliate of Oakwood Capital, Inc. In such capacity, Mr. McCroskey sells securities through OCS and receives commissions. The potential for receipt of commissions and other compensation when Mr. McCroskey directs securities transactions for client accounts through OCS may give Mr. McCroskey an incentive to recommend investment products based on the compensation received, rather than on the client's needs. However, Mr. McCroskey will only recommend securities transactions that he believes are suitable for the client's account and in the best interests of the client. Clients are not required to transact brokerage business with Mr. McCroskey. Clients should be aware that similar services are available elsewhere through entities not affiliated with Mr. McCroskey or Oakwood Capital, Inc.

Mr. McCroskey is also a licensed insurance agent and may recommend and engage in the sale of insurance products offered by various insurance carriers for which he will receive additional compensation. Please be advised that there is a conflict of interest in that there is an economic incentive for Mr. McCroskey to recommend insurance products offered through such insurance carriers. Any commissions received through the sales of insurance policies do not offset advisory fees the client may pay for advisory services provided

by Oakwood Capital. Mr. McCroskey strives to put his clients' interests first and foremost, and clients are not obligated to purchase insurance products through him and may seek similar services elsewhere.
